# 1. NABERS Individual rating fees

These are the NABERS administration fees should you choose to conduct only *one rating* at a time per building.

Due to COVID-19 relief, several ratings are free and are valid from 1 July 2020 – 30 June 2021 unless otherwise specified<sup>1</sup>.

## 2. Rating discounts and deals

Lodging multiple ratings at the same time for each building can save you money on your NABERS fees.

### a. Multiple lodgement discounts

#### i. Office buildings

### NABERS Waste Platform<sup>2</sup>:

## 5. Custom Data Services

This covers all forms of custom data services for NABERS rating data. Fees are billed in half day charge out fees and the total cost is dependent on the time taken to accomplish the request. Charge out rates are as follows:

- Half day = \$1,000
- Full day = \$2,000

a. The exam pass mark is 80% and over

b. If your mark is between 75% and 80%, To become an Accredited Assessor, you will need to resit the exam, but you won't be charged on your first attempt

c. The fail mark is 74% and below. To become an Accredited Assessor, you'll have to resit the exam and will be charged the relevant resit fee

d. You will need to recomplete the course at the full price if you obtain less than 50%.
