## Current deals

50% discount introductory offer for new sectors <sup>1</sup>:

- New sector facilities get 50% off for their first NABERS Energy rating for the first 3 years from date of launch. Current new sector discounts are available for ratings lodged before:
  - Warehouses until 31 August 2025
  - Cold stores until 31 August 2025
  - Non-government schools until 31 July 2027
  - Retail stores until August 31 2027.
- Waste Rating and Waste Verification for first time users:
  - 50% discount introductory offer for first time buildings receiving a waste rating (offices only) or waste verification.

NABERS Energy Commitment Agreement for new sectors <sup>2</sup>:

- Be one of the first three NABERS Energy Commitment agreements in Residential aged care and retirement living, Shopping centres, Data centres, Warehouses and cold stores, non-government schools or Retail stores to qualify for a free Commitment Agreement.

- Thereafter price for a NABERS Energy Commitment Agreement is \$4,605 (small buildings) or \$9,215 (medium to large buildings) including GST.



## Training Courses and Assessor Fees

Training is available to become an Accredited NABERS Assessor. **All fees are including GST.**

## Custom Data Services

This covers all forms of custom data services for NABERS rating data. Fees are billed in half day charge out fees and the total cost is dependent on the time taken to accomplish the request. Charge out rates are as follows:

- Half day = \$1,285
- Full day = \$2,560

A quote will be provided in advance upon request.

Examples include:

- Historical datasets
- Portfolio reporting
- Data trends over time
- Interrogation of data.

Data can be provided as:

- Excel datasets
- PDF data visualisation insights.

- Warehouses until 31 August 2025
- Cold stores until 31 August 2025
- Non-government schools until 31 July 2027
- Retail stores until 31 August 2027.

<sup>2</sup> Free for the first 3 agreements in each sector only.

<sup>3</sup> Includes the Australian Government Department of the Environment and Energy fee. Carbon Neutral Certifications are an extra component of other NABERS ratings (i.e. on top of an Energy or Water rating).

<sup>4</sup> Customers can claim either the 50% CitySwitch discount OR the 50% small tenancy discount.

Also, Hotels, Shopping Centres and Warehouses and Cold Stores (unless assessor has already been supervised prior for Offices). All fees include a supervision fee unless otherwise stated.

<sup>10</sup> The exam resit rules:

- a. The exam pass mark is 80% and over.
- b. If your mark is between 75% and 80%, To become an Accredited Assessor, you will need to resit the exam questions you got wrong, but you won't be charged on your first attempt.
- c. The fail mark is 74% and below. To become an Accredited Assessor, you'll have to resit the exam and will be charged the relevant resit fee.
- d. You will need to recomplete the course at the full price if you obtain less than 50%.
